- Either a valid and current AMERICAN, JAPANESE, AUSTRALIAN, CANADIAN, SHENZHEN, SINGAPORE, UNITED KINGDOM visa or PERMANENT RESIDENT of the stated countries (AJACS)
- A national passport valid for at least (6) months beyond the contemplated stay;
- Return or onward ticket to the next country of destination; and
- No derogatory record with the Bureau of Immigration.
